

KYODO AMERICA LIMITED WARRANTY FOR CANADIAN CUSTOMERS

KYODO AMERICA INDUSTRIES CO., LTD. (KA) warrants to you, the original purchaser, the robotic device for two (2) years of use from the date of original purchase. KA, through any **Canada based** KA authorized dealer (Dealer), will repair or replace, free of charge, any part or parts found to be defective in material and/or workmanship. **This is the exclusive remedy.** This warranty is valid only for units sold through KA LawnBott authorized dealers for home and/or personal use in the United States and Canada.

The purchaser shall be responsible for any costs associated with transporting the unit to and from the Dealer.

The purchaser shall not be charged any diagnostic labor charges, to determine if a warranted part is defective, if the diagnostic work is performed at a Dealer.

The purchaser or owner is responsible for the performance of required maintenance on the unit as defined by the manufacturer in the owner/operator manual. Any failure to perform the required maintenance may void this warranty.

Any warranted part which is not scheduled for replacement as required maintenance, or which is scheduled only for regular inspection to the effect of "repair or replace as necessary" shall be warranted for the warranty period. Any warranted part, which is scheduled for replacement as required maintenance, shall be warranted for the period of time up to the first scheduled replacement point for the part.

KA reserves the right to substitute replacement parts with non-original parts, of equal performance and durability, as is necessary, and in doing so, does not in any way alter its warranty obligation.

Batteries. For a period of one (1) year for **Lithium batteries** and six (6) months for **Lead batteries**, from original date of purchase, KA, through any Dealer, will repair or replace, free of charge, for the original purchaser, any part or parts found to be defective in material and/or workmanship.

There are no warranties on the cutting blade and lamp except for manufacturing failures in material and/or workmanship.

In order to be eligible to receive warranty service, you must present your receipt of purchase or a comparable substitute proof of purchase bearing the date of purchase.

The Warranty does not apply to those units that have been damaged by neglect or misuse. Neglect and misuse shall be defined as any use other than that which is listed in the owner/operator manual for proper use and maintenance of the units. Additionally, this warranty does not apply to those units which malfunction due to any accidental mishandling, alteration, abuse, use of any parts or accessories other than those specified by KA, or other causes beyond KA's control.

The warranty does not cover those parts replaced by normal wear and tear, nor by harmless changes in their appearance, as a result of use.

There are no other express warranties.

Implied warranties including those of merchantability and fitness for a particular purpose **are limited** to two (2) years of use from the original delivery date.

Liabilities for incidental or consequential damage under any and all warranties are excluded.

Some STATES or **PROVINCES** do not allow limitation on how long an implied warranty lasts or exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

This warranty gives you specific legal rights, and you may also have other rights, which vary from **Province**.
